CHINA- UGANDA INDUSTRIAL CAPACITY COOPERATION EXPOSITION



UGANDA National Chamber of Commerce and Industry (UNCCI) President Olive Kigongo and the chinese Ambassador Zheng Zhuqiang presided over the opening ceremony of the China- Uganda Industrial capacity Cooperation Exposition held at Uganda Manufacturers Association grounds.

The expo was the first ever in Uganda and only the third in Africa, after Kenya's and Ethiopia's last year, is a signal that Uganda is moving from being, just a consumer of Chinese products to a key market of its capital goods and equipment.

The expo, which show cased infrastructure construction, energy, mining machines and equipment, agricultural processing machines and automobiles, is a recognition that this country is moving to the next stage of development.

China has become a major investor in our country. Foreign Direct Inflows (FDI) from China into Uganda last year stood at \$270m, the third highest on the continent and growing.

UNCCI, who were partners to the event, see such events as key means to creating engagement between businessmen in China and here at home.

The Expo is planned as an annual event and one can expect after the interest shown in the inaugural edition that it will only grow from strength to strength.

It was good way to expose our businessmen as to the possibilities available in China and in turn make their businessmen aware of the demand for their products. Some mutually beneficial relationships were struck up between the exhibitors and our businessmen. I have no doubt that the fruits of these interactions will be seen very soon.
